



# SC HOSA 2024 FALL LEADERSHIP CONFERENCE CODE OF CONDUCT FORM

**EVERY ATTENDING STUDENT MUST HAVE A COMPLETED FORM. NO electronic signatures will be accepted.**

Maintaining a strong reputation allows you to feel proud of yourself and your organization. HOSA members are known for upholding high standards and it is essential to maintain this reputation at all HOSA events. In this context, HOSA members include both students and advisors. The HOSA advisor should exemplify and promote integrity, leadership skills, and good sportsmanship among all students, setting a positive example for others consistently.

1. Each member of SC HOSA should conduct themselves in a manner that reflects positively on themselves, their school, and the SC HOSA organization.
2. The student's behavior is the responsibility of both the individual student and the local chapter advisor. Students are required to keep the advisor informed of their activities and whereabouts at all times.
3. Nametags and proper attire must be worn to all HOSA events.
4. The students and the advisors are expected to attend all conference sessions, be on time and show respect to all presenters, other conference attendees and on-site personnel.
5. Members must promptly report any accidents, injuries, or illnesses to their local advisor. Advisors are responsible for informing SC HOSA, Inc., about any such incidents.
6. If a student or advisor is involved in or has knowledge of stealing, vandalism, or improper or disruptive behavior, the student and his/her parents/guardians or the advisor will be expected to pay any and all damages, including transportation home. The local school principal or director will be notified immediately.
7. HOSA members may NOT use or have in his/her possession any alcohol or illegal drugs at any time. HOSA members may not purchase, consume or be under the influence of alcohol or drugs. Tobacco products are illegal for all persons under 21 years of age. **Violators will be removed from the conference at their parent's/guardian's or school's expense.**
8. Members are expected to follow the policies of their school and local Board of Education.
9. If staying overnight, guests of the opposite sex are not allowed in the same room without an approved chaperone.
  - a. Any additional room charges are the responsibility of the individual student making those charges.
10. As a delegate to the 2024 Fall Leadership Conference, students will be aware of and follow any additional safety protocols.
11. As a delegate to the 2024 HOSA Fall Conference, permission is granted to make photographs, video tapes, broadcasts, and/or sound recordings, separately or in combination, available to reproduction for educational and promotional purposes by SC HOSA.
